Minimum qualification for eligibility of different categories of technical personal is given below:

(A) For all urban local bodies and Nabadiganta Industrial Township Authority except Kolkata and Howrah Municipal Corporation and urban local bodies in hill areas:

2.	Licensed Building Surveyor class I	<p>1. A Bachelors' degree in Civil Engineering or Construction Engineering or Architecture from a recognized university or an equivalent engineering qualification recognized by the Government and shall not have less than 5 years' experience in planning, design and execution of building works including sanitary and plumbing works related to buildings in areas other than the Municipalities in hill areas.</p> <p style="text-align: center;">OR</p> <p>2. A diploma in Civil Engineering or Architecture from a recognized university or an equivalent engineering qualification recognized by the Government and shall not have less than 10 years' experience in planning, design and execution of building works including sanitary and plumbing works related to buildings in areas other than the Municipalities in hill areas.(Amendment Notification No 152-ma_2017-2018_25.02.2018)</p>

Note: It may please be noted that initially no enrolment fees may be deposited by the applicant along with their application form. Only the selected applicants may deposit their enrollment fees accordingly to the selected categories as stated above. The mode of deposition of enrollment fees may be intimated in due course.

Enrolment fees are as follows:

Technical Personnel	For 1 year	for 3 year
Class I	Rs. 1500/-	Rs. 4200/-
Class II	Rs. 1000/-	Rs. 2800/-

Late fees for renewal of License: Rs. 250/- per month or part thereof

Fees for issuing duplicate card Rs. 1200/-

Applicants may be asked to appear for an interview in the prescribed date and time which may be intimated later on through email or letter. Applicant may apply for more than one category and in that case they should submit separate application for each category. **Last date of submission of application to the Chairman is 20.07.2022.** No application shall be entertained after the last date of submission mentioned above.

All candidates who are interested for enrollment for licensed building surveyor class I and Class II should submit their application in prescribed form along with self attested photocopy of his/her educational qualification and work experience to the Chairman in which he/she intends to enroll his/her name within that time mentioned above. The top of the envelope contains the application, should mention the category that is Licensed Building Surveyor class I or Class II.
