
Intending tenderer(s) should abide by the following conditions for execution of the work as follow:-

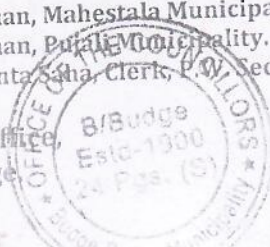


